2. E-MAIL:

It is the responsibility of each HUB member to ensure the HUB Office Manager has their correct e-mail address. Only one Official e-mail address is allowed per member. 3. PROXY:

The Letter of Proxy MUST contain the HUB member's name, Membership Number, and Signature. The Letter of Proxy must also declare the name of the HUB member acting as proxy.

The HUB member acting as proxy will present the Letter of Proxy at the Annual Meeting to obtain the eligible member's ballot for voting purposes.

BY-LAWS AMENDMENTS

QUESTION 1. ARTICLE VII: ELECTIONS. Section 1

Delete:

There shall be a nominating committee of three regular or life members elected by the board of directors no later than the month of September. Said committee shall prepare a slate of no less than three and no more than five candidates for election to the board of directors for the ensuing year. This slate, which is to be presented at the November meeting of the board of directors, will be included in the notice of the annual meeting and provided to the membership no later than 30 days before the Annual Meeting.

Replace with:

There shall be a nominating committee of three regular or life members elected by the board of directors no later than the month of September. *Said committee shall prepare a slate of preferably five (5) candidates and no less than four (4) candidates* for election to the board of directors for the ensuing year. This slate, which is to be presented at the November meeting of the board of directors, will be included in the notice of the annual meeting and provided to the membership no later than 30 days before the Annual Meeting.

QUESTION 2. ARTICLE VIII: DUTIES OF DIRECTORS AND OFFICERS. Section 11

Delete

- (a) A director of the corporation must approve expenditures not in excess of \$100.00.
- (b) Two officers of the corporation must approve expenditures over \$100.00 but not in excess of \$500.00.
- (c) Expenditures over \$500.00 must be approved by a majority of the board of directors.

Replace with:

- (a) The treasurer is authorized to spend funds in accordance with the Budget approved by the Board of Directors for the current fiscal year.
- (b) At any time during the fiscal year, the Board of Directors can amend the Budget to increase or decrease authorized spending of Budgeted funds.
- (c) Expenditures required for the operations of the organization not included in the budget, not in excess two hundred fifty dollars (\$250.00) can be authorized by the President, with the approval of one other member of the Board of Directors and with concurrence by the Treasurer that funds are available.
- (d) For expenditures of more than two hundred fifty dollars (\$250.00), details must be transmitted to all members of the Board of Directors and must be approved by a majority of the Board of Directors with concurrence by the Treasurer that such funds are available. Such approval can be secured by use of an electronic vote, which must be forwarded to the Secretary and included in the Minutes of the next scheduled Board of Directors meeting. For any such expenditure of funds the "Minutes" entry must state the nature of the expense, which Director proposed the need, with the second and a list of the Board of Directors voting.

HE HUB Division election for Board of Directors and By-Law changes is upon us. This year, five capable candidates are running for three positions on the Board. The instructions for voting are presented on page 2. The bio-sketches of candidates are provided on this and the following page. The proposed changes in the by-laws are presented on page 3. If you elect to mail your ballot in advance, it is provided on page 7.




